#### PERFORMANCE REPORT

#### Foreword to the Accounts

#### Introduction

The British-American Parliamentary Group (BAPG) was formed in 1937 to promote closer relations and understanding between Members of both Houses of Parliament of the United Kingdom and Members of both Houses of Congress of the United States of America by providing opportunities for discussion on problems common to both countries and for the exchange of visits and information. The BAPG Objectives, Activities and Rules were formally adopted on 5 July 1967 and have since been subject to minor amendments, with the latest in 2018.

The BAPG acts as an autonomous body within Parliament. It appoints its own administrative staff to carry out its objectives and the rules of the BAPG define the limitations on its powers.

The management of the BAPG is vested in the Executive Committee. The Honorary Secretary, who is a member of the Executive Committee, is primarily responsible for the BAPG's activities; the Administrator, who is an official of the BAPG and is not a member of the Executive Committee, is responsible for the executive work of the BAPG. The Chair of the BAPG is the Prime Minister. The two Vice-Chairs from the House of Commons are normally of Cabinet and Shadow Cabinet rank.

#### Principal Activities of the British-American Parliamentary Group

The format of the annual programme of activities has historically consisted of: one Annual Parliamentary / Congressional Conference; one 'familiarisation' visit to the United States, run conjointly with the United States Department of State and the United States Embassy London, for members with no or little prior experience of the US to learn about the US legislative process and the cultural and political influences in US society; attendance at a biennial course conducted by the Institute of Politics at the Harvard Kennedy School for newly elected Members of Congress. In off years, we would look to undertake an ad hoc thematic visit to the United States in conjunction with the FCDO and US posts to look at a particular policy issue (budget allowing). Also, every four years, during a Presidential election year, we would look to send members to the Democratic and Republican National Party Conventions to see Presidential candidate selection.

Various other activities are held in the United Kingdom with distinguished visitors from the United States.

In 2023-24, it was the turn of the Senate BAPG to host the Annual Parliamentary / Congressional Conference in the US, but the Democratic leadership in the Senate has not yet appointed a new chair to the Senate BAPG to succeed Senator Patrick Leahy's (D-VT), who retired from Congress in January 2023, after having served 21 years as chair or vice chair of the Senate BAPG. With the role vacant, it has not been possible to organise a conference.

We had also hoped to host the deferred 2022 Annual Parliamentary / Congressional Conference here in the UK with a delegation from the US House of Representatives, but our US counterparts were not able to organise a delegation for the scheduled dates of the exchange.

This year, we facilitated two specialist delegation visits to the US, one of which had originally been intended in 2022-23 financial year, but crossed over into 2023-24 financial year (the scheduled dates postponing from March to April 2023):

In April 2023, four members took part in a specialist delegation visit to Texas in conjunction with the British Consulate General Houston to better understand the commercial opportunities afforded in the region and the political power that sits outside the beltway.

In March 2024, four members took part in a specialist delegation visit to Kansas and Missouri in conjunction with the British Consulate General Chicago to look at how American industry and agriculture is regenerating and to explore the opportunities for Anglo-American cooperation.

In July 2023, five members participated in the annual 'familiarisation' or legislative exchange co-sponsored with the US Department of State and the US Embassy London to learn about the US legislative process.

#### Relationship with the House of Commons Commission and House of Lords Commission

The BAPG is funded mainly by a grant from the House of Commons Commission and the House of Lords Commission in the proportion 70:30. The BAPG submits a detailed income and expenditure budget together with bids for expenditure on a rolling three-year programme, usually in September each year, or at the request of the Clerks of the Overseas Offices, who are the budget holders on behalf of the House of Commons Commission and House of Lords Commission. Approval of the budget and the amount of the grant for the coming year is agreed in the first quarter of the following year. The grant is normally paid in one instalment, usually in April each year. In 2023-24, both Houses paid additional in-year funds in February 2024 to cover the additional cost of a pay award to the Administrator in line with the House of Commons pay award to all its staff.

#### Results for the Year

The Statement of Comprehensive Net Income (page 17) shows that the BAPG had a net operating surplus of £9,924 for the year 2023-24 (in 2022-23 the BAPG had a net operating deficit of £65,078). The Parliamentary grant for the year was £131,256 (£127,261 was received in April 2023 and £3,995.14 was received in February 2024 (in 2022-23 the grant funding was £124,765). As of 31st March 2024, the BAPG holds £118,907 in reserves (page 17). This includes £26,405 for the deferred 2022 Annual Parliamentary / Congressional Conference in the UK, £40,000 for the 2023 Annual Conference with the Senate BAPG in the US and £14,274 to fund the anticipated budget shortfall in financial year 2024-25 so that the Group may deliver the BAPG's traditional programme of activities.

While the reserves currently exceed the expected one fourth of maximum annual funding, the BAPG plans to draw down on the reserves in 2024-25 financial year, circumstances permitting.

#### **Prompt Payment Initiative**

In line with best commercial practice, it is BAPG policy to pay bills in accordance with contractual conditions. Where no such conditions exist, it aims to pay within 30 days of receipt of goods and services or on presentation of a valid invoice, whichever is the later. During 2023-24, no interest has been paid to suppliers for the late payment of invoices.

#### **Reduction of Carbon Emissions**

In line with government policy, the BAPG used to off-set its carbon emissions from flights via the purchase of Gold Standard Certified Emissions Reduction (CER) credits, facilitated by the Government Carbon Offsetting Facility, under the Kyoto Protocol's Clean Development Mechanism (CDM).

UK government policy is no longer centred on carbon offsetting, now focusing on methods to reduce carbon emissions, via measurement, baseline and continuous improvement/reduction, as well as using greener forms of energy.

The BAPG plans its programme of activities mindful of this policy, through measures such as flying delegates to the US in Premium Economy, travelling by train internally in the US, where possible, and arranging ground transport with lower polluting vehicles.

#### **Going Concern**

The Accounting Officer considers the BAPG a going concern, given the business involvement established in BAPG events, via financial sponsorship, as well as the expected continuation of funding from the House of Commons and House of Lords. The BAPG's grant funding is paid by the House of Commons (70% share) and the House of Lords (30% share) and is included in their supply estimates each year along with those of the three other like grant funded interparliamentary groups (BGIPU, CPA-UK and BIPA). The BAPG received 50% of its maximum annual funding allowance 2025-26 in Q1 and is submitting a request for the balance of funding in Q3. The BAPG is currently preparing a Funding Request for the 2026-27 financial year, to be submitted to the Parliamentary Budget Holders in mid-September 2025. A decision is expected from the House of Commons Commission and the House of Lords Commission in early January 2026. A final Request for Payment of the funding allowance 2026-27 will be submitted in March 2026, with the expectation of payment in April 2026. We are confident that the going concern assumption remains appropriate for the preparation of the financial statements.

#### **ACCOUNTABILITY REPORT**

#### Statement of Accounting Officer's Responsibilities

Under the Financial Memorandum, the House of Commons Commission and the House of Lords Commission have directed the BAPG to prepare for each financial year a statement of accounts to the year ended 31 March. The accounts are prepared on an accruals basis and must give a true and fair view of the state of affairs of BAPG and of its income and expenditure and cash flows for the financial year.

In preparing the accounts, the Accounting Officer is required to:

- give due regard to the procedures laid down in the Financial Memorandum, including relevant accounting and disclosure requirements, and apply suitable accounting policies on a consistent basis;
- make judgments and estimates on a reasonable basis;
- state whether applicable standards have been followed and disclose and explain any material departures in the financial statements; and
- prepare the financial statements on the going concern basis, unless it is inappropriate to presume that the BAPG will continue in operation.

The Executive Committee has appointed as Accounting Officer, the Joint Honorary Treasurer of the opposite party to the Honorary Secretary, The Rt. Hon. John Spellar, MP. The responsibilities of an 'Accounting Officer' include responsibility for the propriety and regularity of the BAPG's grant funding, for keeping proper records, for safeguarding the BAPG's assets, as set out in the Financial Memorandum agreed between the BAPG, the House of Commons Commission and the House of Lords Commission, for ensuring that the annual report and accounts as a whole is fair, balanced and understandable and for taking personal responsibility for the annual report and accounts and the judgments required for determining that it is fair, balanced and understandable.

#### **Provision of Information to Auditors**

As far as the Accounting Officer is aware, there is no relevant audit information of which the BAPG's auditor, the Comptroller and Auditor General and the National Audit Office (NAO), are unaware. In addition, the Accounting Officer has taken all the steps necessary to make himself aware of any relevant audit information and to establish that the BAPG's auditors are aware of that information.

#### **Governance Statement**

The British-American Parliamentary Group (BAPG) maintains a system of governance that supports the achievement of the objectives and activities of the BAPG, whilst safeguarding the public funds and assets in a manner that is consistent with the Financial Memorandum issued by the House of Commons Commission and the House of Lords Commission for the use of the Group's grant. In discharging its responsibilities, the BAPG has had regard to the principles of the Corporate Governance Code for Central Government.

#### Governance Framework

The BAPG acts as an autonomous body within Parliament. The management of the BAPG is vested in an Executive Committee. The Honorary Secretary and Joint Honorary Treasurers, who are nominated by the Executive Committee and ratified each year at the Annual General Meeting as additional members of the Executive Committee with full voting rights, are primarily responsible for the Group's activities. The Chairman of the Group is the Prime Minister. The two Vice-Chairs from the House of Commons are normally of Cabinet and Shadow Cabinet rank.

The Group's rules are set out in a single constitutional document and detail the administrative arrangements and membership of the Group.

The day-to-day activities are the responsibility of the Administrator who is employed by the Executive Committee and operates under the general direction of the BAPG Officers to implement its policy decisions.

The Group's rules provide that the Executive Committee shall meet four times a year, between one year's AGM and the next. The Executive Committee may determine a time and place for an Annual General Meeting of members to which it submits a report of its proceedings. The rules also allow for the Executive Committee to call Special General Meetings to consider and determine any matter of interest and importance that may arise.

None of the members of the Executive Committee received a remuneration for their role. Details on the composition of the Executive Committee and meeting attendance can be found on pages 8 and 9 respectively.

#### Relationship with Sponsor: House of Commons Commission and House of Lords Commission

The House of Commons Commission and House of Lords Commission provide funding to the BAPG by way of a grant in the proportion 70:30.

The BAPG's relationship with its funding sponsors is embodied in a Financial Memorandum.

The Financial Memorandum defines the group's status and governance arrangements, its funding, budgeting and planning requirements, financial controls, requirements for audit and assurance, other provisions, details of the services provided by both Houses and delegated financial authority. In summary, the Memorandum ensures that BAPG's activities are funded, governed, and audited transparently, with strong oversight from Parliament, while maintaining its independence.

The Financial Memorandum is reviewed at least once every three years. A new version of the Memorandum was introduced in April 2012, which strengthened financial reporting and set limits on reserves. Reviews followed in 2013 (light touch, minor amendments), 2016–17 (more substantive updates, audit-related improvements), 2020–21 (clarifications and new House policies across all inter-parliamentary groups), 2023-2024 (substantive changes: moving forward the annual funding request deadline, with the possibility of extension; accordance with precautionary exclusion actions taken against any member of either House in its activities; formal record of Parliament's practical support to the IPGs (office space, passes, payroll, IT, etc)).

The Clerks of the respective InterParliamentary Relations Offices (formerly the Overseas Offices) attend meetings of the BAPG Executive Committee to provide assurance to the House of Commons Commission and House of Lords Commission that funding is being disbursed in accordance with the purposes and principles set out in the Financial Memorandum as well as to provide such advice and assistance as requested.

The Executive Committee appoints an Accounting Officer from its membership, normally one of the Officers (either of the Joint Honorary Treasurers or the Honorary Secretary) to ensure that the uses to which the Group puts funds received from the grant are consistent with the purposes for which the grant was given and comply with any conditions attached to them, including the provisions of the Financial Memorandum.

The BAPG's accounts and the activities that underpin them are currently subject to external audit by the Comptroller and Auditor General supported by the National Audit Office (NAO). The NAO carry out their audits in accordance with the International Standards on Auditing (UK) and each year report the results of their work to the BAPG's Executive Committee.

Internal Audit services of both Houses may also be used to provide assurance to the sponsors and to the BAPG Executive Committee. The Internal Audit services have the right of access to all the BAPG records, operations and physical properties of the body and to the Executive Committee members, employees and contractors, as set out in the Financial Memorandum. An internal audit was last carried out in 2017-18 to provide assurance that the governance processes in place were adequate to leave the Accounting Officers of each House able to discharge their responsibility to 'ensure prudent management of grant in aid funds, achieve value for money, and ensure that grants are used as envisaged while allowing recipients reasonable freedom to take their own decisions'. Following the audit, the internal audit team reported that they were "able to provide substantial assurance that the processes in place within BAPG result in the intended objectives being achieved." There has been no recent work undertaken by the internal audit team on the BAPG. Furthermore, there have been no changes in process since the Independent Auditor's last review.

#### The Group's Governance Activities in 2023-24

The Executive Committee met virtually on four occasions in 2023-24 to consider matters that are set out in the Annual Report of the Executive Committee. Amongst other things, the Committee examined the Group's draft programme of activities for the present year and estimated costs; reviewed the Group's budgetary position and forecast budget for 2024-25; analysed the Group's accounts for 2022-23 and the annual report of the Honorary Secretary, as well as other matters for discussion and endorsement by the Annual General Meeting.

# **Quality of Data**

In advance of each Executive Committee meeting, an extract of the Treasurer's Report is circulated to the committee, detailing the current finances of the Group, the known liabilities for the year to 31<sup>st</sup> March and the anticipated balance at the year-end, after the costs have been deducted. This is accompanied by a copy of the Minutes of the last meeting and a summary of the activities that have taken place since the last meeting and those planned for the future. The Committee is also sent at periodic intervals updates on the Group's membership figures and a copy of the Group's latest Risk Register for review. This data information assists the Committee in discharging its responsibilities and achieving the objectives and activities of the BAPG, whilst safeguarding the public funds and assets in a manner that is consistent with the Financial Memorandum and the principles of the Corporate Governance Code for Central Government.

#### **Risk Management**

The risk management process is the responsibility of the Executive Committee and it oversees a risk register which identifies and evaluates possible risks to the Group and sets out the internal controls or mitigating actions in place to manage the risks. These risk management and internal control systems have been in place for the year under review and up to the date of approval of the annual report and accounts. It is the responsibility of the Committee to regularly appraise the existing risks and to recommend action where necessary. Importantly, this process is designed to manage risk to a reasonable level, rather than to eliminate all risk. In doing this, it can provide only reasonable and not absolute assurance of effectiveness.

The risk register currently identifies 13 risks which fall within the low risk areas after mitigating actions have been taken. The major operational risk is management override of controls. Management is in a unique position to perpetuate fraud because of its ability to manipulate accounting records and prepare fraudulent financial statements by using its position to override controls that otherwise appear to be operating effectively. This is mitigated by the segregation of duties; most payments are by cheque (except for the Administrator's net pay, which is paid by Standing Order every month; Employer and Employee pension contributions, which are required by the Cabinet Office to be paid on-line and exceptional ad hoc on-line payments, when 'fast payment' is required), which require two of three signatories. Furthermore, there are agreed authorisation/delegation limits on financial expenditure, as detailed in the annex of the Financial Memorandum.

An ongoing area of significant concern, which the BAPG Executive Committee is monitoring, is the future sustainability of the BAPG's traditional programme of activities. After five years of no inflationary uplift to the grant (2010-2015) and a 2% cap to the uplift in 2022-23 and 2023-24 financial years, at a time of unprecedented inflation in the UK and US, representing a real cash cut to funding, the current base line grant is no longer sufficient to fund the BAPG's traditional programme on a four year cycle. This is evidenced by the BAPG's reliance on reserves to make-up the budget shortfall. We anticipate by 2027-28 financial year, when the Annual Conference reverts to the United States for the next two years (with added airfare and hotel accommodation costs), insufficient reserves to make up the budget shortfall and having to request to the Parliamentary authorities an increase in the Group's baseline funding going forward if we are to continue to deliver the BAPG's traditional programme of activities.

In 2016, the BAPG Executive Committee considered other possible sources of finance to help offset the anticipated budget shortfall, including inviting business involvement in BAPG events. We have since had some success with this, particularly in respect of the 2017, 2018 and 2021 Annual Conferences, which were hosted in the UK, and the annual reception for the American Ambassador. While we cannot guarantee this revenue stream for future activities, particularly when the Annual Conference is hosted in the US, we will continue to utilise it as an option when we can, to help reduce programme costs and leverage funds for the BAPG's core function of establishing people to people relations via exchange of visits.

Overall, given the business involvement established in BAPG events, as well as the expected continuation of funding from the House of Commons and House of Lords, we are confident that the going concern assumption remains appropriate for the preparation of the financial statements.

#### **Personal Data Related Incidents**

The BAPG had no personal data-related incidents during the reporting year.

#### Changes to the composition of the Executive Committee up to the signature date of the Accounts 2023-24

\_\_\_\_\_\_

The Group's Annual General Meeting 2023 took place on 12<sup>th</sup> July at which members of the 2023-24 Executive Committee were elected. All existing Members of the Executive Committee 2022-23 were re-elected, excepting Conor McGinn, MP (Labour) and Gavin Newlands, MP (SNP), who both stood down from the committee at the AGM. The Rt. Hon. John Healey, MP (Labour) and Dr. Lisa Cameron, MP (SNP) were elected to the vacant positions. Note, Dr. Lisa Cameron, MP later defected to the Conservative Party in October 2023 and in so doing nullified her position as an opposition MP on the BAPG Executive Committee. The place remains vacant on the committee. Also, The Rt. Hon. Esther McVey, MP (Conservative) was appointed a Minister in the November 2023 cabinet reshuffle which meant she could no longer serve as a member of the BAPG Executive Committee thereby creating a vacancy on the government side, which remains vacant.

The BAPG Vice Chairs in the Commons, The Rt. Hon. Ben Wallace, MP (Conservative) and The Rt. Hon. John Healey, MP (Labour) both completed their three year terms at the AGM in July 2023 and were succeeded by The Rt. Hon. James Cleverly, MP (Conservative) and The Rt. Hon. David Lammy, MP (Labour).

#### Review of the Effectiveness of the Governance

The Accounting Officer has responsibility for maintaining effective governance and periodically to review the processes and procedures that are in place. The Accounting Officer's statement is set out below.

My review of the BAPG's governance is informed by the deliberations of the British-American Parliamentary Group's Annual General Meeting, the decisions of the Executive Committee, as well as the views of the Administrator, the Honorary Secretary and fellow Joint Honorary Treasurer of the BAPG, who have day to day responsibility for the governance processes and procedures.

I have also had regard to guidance on internal control and financial management issued by the House of Commons Commission and House of Lords Commission, under the auspices of the Financial Memorandum, as well as the comments made by the external auditors, the Comptroller and Auditor General, supported by the National Audit Office (NAO), in their audit of the BAPG Accounts and the activities that underpin them, which is carried out in accordance with International Standards on Auditing (UK) and each year reports the results of their work to the BAPG's Executive Committee. As far as I am aware, there have been no significant internal controls issues raised during the year.

On an enduring basis, I advise the BAPG's Executive Committee on the implications of the periodic reviews of the BAPG's governance processes and procedures. I intend to ensure that the BAPG continues to maintain a reliable system of governance.

I consider that the Executive Committee has an effective stewardship over the resources of the Group.

# THE INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF THE BRITISH-AMERICAN PARLIAMENTARY GROUP

Opinion on financial statements

I have audited the financial statements of the British-American Parliamentary Group for the year ended 31 March 2024 under the Basis of Agreement.

The financial statements comprise the British-American Parliamentary Group's

- Statement of Financial Position as at 31 March 2024;
- Statement of Comprehensive Net Expenditure, Statement of Cash Flows and Statement of Changes in Taxpayers' Equity for the year then ended; and
- the related notes including the significant accounting policies.

The financial reporting framework that has been applied in the preparation of the financial statements is applicable law and UK adopted international accounting standards.

In my opinion, the financial statements:

- give a true and fair view of the state of the British-American Parliamentary Group's affairs as at 31 March 2024 and its net operating income or the year then ended; and
- have been properly prepared in accordance with the HM Treasury's Government Financial Reporting Manual as adapted or interpreted for the Houses of Parliament context and the Financial Memorandum as approved by the House of Commons Commission and House of Lords Commission.

# **Opinion on regularity**

In my opinion, in all material respects, the income and expenditure recorded in the financial statements have been applied to the purposes intended by Parliament and the financial transactions recorded in the financial statements conform to the authorities which govern them.

# **Basis for opinions**

I conducted my audit in accordance with International Standards on Auditing (UK) (ISAs UK), applicable law and Practice Note 10 Audit of Financial Statements and Regularity of Public Sector Bodies in the United Kingdom (2024). My responsibilities under those standards are further described in the Auditor's responsibilities for the audit of the financial statements section of my report.

Those standards require me and my staff to comply with the Financial Reporting Council's *Revised Ethical Standard 2024*. I am independent of the British-American Parliamentary Group in accordance with the ethical requirements that are relevant to my audit of the financial statements in the UK. My staff and I have fulfilled our other ethical responsibilities in accordance with these requirements.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my opinion.

#### Conclusions relating to going concern

In auditing the financial statements, I have concluded that the British-American Parliamentary Group's use of the going concern basis of accounting in the preparation of the financial statements is appropriate.

Based on the work I have performed, I have not identified any material uncertainties relating to events or conditions that, individually or collectively, may cast significant doubt on British-American Parliamentary Group's ability to continue as a going concern for a period of at least twelve months from when the financial statements are authorised for issue.

My responsibilities and the responsibilities of the Accounting Officer with respect to going concern are described in the relevant sections of this report.

The going concern basis of accounting for the British-American Parliamentary Group is adopted in consideration of the requirements set out in HM Treasury's Government Financial Reporting Manual, which requires entities to adopt the going concern basis of accounting in the preparation of the financial statements where it is anticipated that the services which they provide will continue into the future.

#### Other Information

The other information comprises information included in the Annual Report but does not include the financial statements and my auditor's report thereon. The Accounting Officer is responsible for the other information.

My opinion on the financial statements does not cover the other information and, except to the extent otherwise explicitly stated in my report, I do not express any form of assurance conclusion thereon.

My responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or my knowledge obtained in the audit, or otherwise appears to be materially misstated.

If I identify such material inconsistencies or apparent material misstatements, I am required to determine whether this gives rise to a material misstatement in the financial statements themselves. If, based on the work I have performed, I conclude that there is a material misstatement of this other information, I am required to report that fact.

I have nothing to report in this regard.

#### **Opinion on other matters**

In my opinion, based on the work undertaken in the course of the audit:

- the parts of the Accountability Report subject to audit have been properly prepared in accordance with HM
   Treasury's Government Financial Reporting Manual as adapted or interpreted for the Houses of Parliament
   context; and
- the information given in the Performance and Accountability Reports for the financial year for which the financial statements are prepared is consistent with the financial statements and is in accordance with the applicable legal requirements.

# Matters on which I report by exception

In the light of the knowledge and understanding of the British-American Parliamentary Group and its environment obtained in the course of the audit, I have not identified material misstatements in the Performance and Accountability Reports.

I have nothing to report in respect of the following matters which I report to you if, in my opinion:

- adequate accounting records have not been kept by the British-American Parliamentary Group or returns adequate for my audit have not been received from branches not visited by my staff; or
- I have not received all of the information and explanations I require for my audit; or
- the financial statements and the parts of the Accountability Report subject to audit are not in agreement with the accounting records and returns; or
- the Governance Statement does not reflect compliance with HM Treasury's guidance.

#### Responsibilities of the Accounting Officer for the financial statements

As explained more fully in the Statement of Accounting Officer's Responsibilities, the Accounting Officer is responsible for:

- maintaining proper accounting records;
- providing the C&AG with access to all information of which management is aware that is relevant to the preparation of the financial statements such as records, documentation and other matters;
- providing the C&AG with additional information and explanations needed for his audit;
- providing the C&AG with unrestricted access to persons within the British-American Parliamentary Group from whom the auditor determines it necessary to obtain audit evidence;
- ensuring such internal controls are in place as deemed necessary to enable the preparation of financial statements to be free from material misstatement, whether due to fraud or error;

- preparing financial statements which give a true and fair view in accordance with HM Treasury's Financial Reporting Manual as adapted or interpreted for the Houses of Parliament context;
- preparing the annual report in accordance with HM Treasury's Financial Reporting Manual as adapted or interpreted for the Houses of Parliament context; and
- assessing the British-American Parliamentary Group's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Accounting Officer anticipates that the services provided by the British-American Parliamentary Group will not continue to be provided in the future.

#### Auditor's responsibilities for the audit of the financial statements

My responsibility is to audit and express an opinion on the financial statements in accordance with the applicable law and International Standards on Auditing (UK) (ISAs (UK)).

My objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue a report that includes my opinion. Reasonable assurance is a high level of assurance but is not a guarantee that an audit conducted in accordance with ISAs (UK) will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

#### Extent to which the audit was considered capable of detecting non-compliance with laws and regulations including fraud

I design procedures in line with my responsibilities, outlined above, to detect material misstatements in respect of non-compliance with laws and regulations, including fraud. The extent to which my procedures are capable of detecting non-compliance with laws and regulations, including fraud is detailed below.

# Identifying and assessing potential risks related to non-compliance with laws and regulations, including fraud

In identifying and assessing risks of material misstatement in respect of non-compliance with laws and regulations, including fraud, I:

- considered the nature of the sector, control environment and operational performance including the design of the British-American Parliamentary Group's accounting policies, key performance indicators and performance incentives.
- inquired of management, and those charged with governance, including obtaining and reviewing supporting documentation relating to British-American Parliamentary Group's policies and procedures on:
  - identifying, evaluating and complying with laws and regulations;
  - o detecting and responding to the risks of fraud; and
- the internal controls established to mitigate risks related to fraud or non-compliance with laws and regulations
  including the British-American Parliamentary Group's controls relating to the British-American Parliamentary
  Group's compliance with the Financial Memorandum agreed with the House of Commons Commission and House
  of Lords Commission, and Managing Public Money inquired of management, and those charged with governance
  whether:
  - they were aware of any instances of non-compliance with laws and regulations;
  - o they had knowledge of any actual, suspected, or alleged fraud;
- discussed with the engagement team regarding how and where fraud might occur in the financial statements and any potential indicators of fraud.

As a result of these procedures, I considered the opportunities and incentives that may exist within the British-American Parliamentary Group for fraud and identified the greatest potential for fraud in the following areas: revenue recognition, posting of unusual journals, complex transactions and bias in management estimates. In common with all audits under ISAs (UK), I am required to perform specific procedures to respond to the risk of management override.

I obtained an understanding of the British-American Parliamentary Group's framework of authority and other legal and regulatory frameworks in which the British-American Parliamentary Group operates. I focused on those laws and regulations that had a direct effect on material amounts and disclosures in the financial statements or that had a fundamental effect on the operations of the British-American Parliamentary Group. The key laws and regulations I considered in this context included HM Treasury's Government Financial Reporting Manual as adapted or interpreted for the Houses of Parliament context, Managing Public Money, employment law and tax legislation.

# **Audit Response to Identified Risks**

To respond to the identified risks resulting from the above procedures:

- I reviewed the financial statement disclosures and testing to supporting documentation to assess compliance with provisions of relevant laws and regulations described above as having direct effect on the financial statements;
- I enquired of management and those charged with governance concerning actual and potential litigation and claims;
- I reviewed minutes of meetings of those charged with governance and the Executive Committee and internal audit reports;
- I addressed the risk of fraud through management override of controls by testing the appropriateness of journal entries and other adjustments; assessing whether the judgements on estimates are indicative of a potential bias; and evaluating the business rationale of any significant transactions that are unusual or outside the normal course of business.

I communicated relevant identified laws and regulations and potential risks of fraud to all engagement team members and remained alert to any indications of fraud or non-compliance with laws and regulations throughout the audit.

#### Notes to the Accounts

#### 1. Statement of accounting policies

These financial statements have been prepared in accordance with the 2023-24 Financial Reporting Manual (FReM) as adapted or interpreted for the House of Commons context which applies International Financial Reporting Standards (IFRS). Where the FReM permits a choice of accounting policy, the accounting policy which is judged to be the most appropriate to the BAPG for the purpose of giving a true and fair view has been selected. The policies adopted by the BAPG are described below. They have been applied consistently in dealing with items that are considered material to the accounts.

#### a. Impending application of newly issued accounting standards

IFRS 17, which will replace IFRS 4, is currently expected to be implemented in financial year 2025-26. The standard applies to issued insurance contracts and the reporting of these in the financial statements to provide comparability and increase transparency. BAPG does not act as an insurer in any insurance contracts, so there should be no impact on 2025-26 accounts

#### 1.1 Non-current assets

Immaterial items of office equipment are written off as expenditure, in full, in the year of acquisition. There have been no new assets purchased in 2023-24.

#### 1.2 Operating income

IFRS 15 (Revenue from Contracts with Customers) is applied as standard and sets out the key recognition and measurement criteria in respect of income.

Such income relates directly to the operating activities of the BAPG and principally comprises of Parliamentary grants, Annual Subscriptions, Life Subscriptions, donations and interest on the bank deposit accounts.

Parliamentary Grant income is recognised in full in the financial year to which the grant relates, with any amounts received in advance or after the year-end deferred or accrued respectively.

Annual Subscriptions cover a 12-month period from 1st April each year. Annual Subscriptions paid between 1st January and 31st March each year are treated as subscriptions paid in advance (deferred income).

Income received from Life Subscriptions is deferred over a period of 10 years (two terms of Parliament) and released on an annual basis.

#### 1.3 Gains and losses

The BAPG does not regularly experience gains or losses but these would be recognised in the Statement of Comprehensive Net Income.

#### 1.4 Taxation

From 6 April 2016, banks and building societies have paid gross (untaxed) interest on savings accounts.

The 2023-24 Accounts show gross interest received of £2,435 as a result, the total tax liability for 2023-24 is £462 (2022-23 £202 liability) based on a Corporation Tax rate of 19% for 2023-24; 2022-23: 19%.

# 1.5 Expenditure

The British-American Parliamentary Group pays all the associated costs of events it organises, however, where it collaborates with a partner, such as BritishAmerican Business or The Ditchley Foundation on an event, and their guests join BAPG members at the event, they may cover the cost of venue hire and refreshments.

Of the £3,455 deferred at the end of 2022-23, £45 annual subscription income and £752 lifetime subscription income was recognised as income during 2023-24.

Deferred income at 31 March 2024 comprised £3,116 relating to subscriptions, and £109,534 grant income from the House of Commons, received in March 2024, but relating to 2024-25 financial year.

# 10. Related-party transactions

The House of Commons and the House of Lords are regarded as related parties, providing grant to the Group under the terms provided by the Financial Memorandum. In addition, the House of Commons provides free accommodation to the Group as well as accounting services at the year end.

The House of Commons and House of Lords provided the BAPG with a combined grant of £131,256 in 2023-24 (£124,765 in 2022-23).

In addition, during March 2024, the BAPG also received £109,534 grant income that relates to the 2024-25 financial year. This has been deferred at year end.

During 2023-24, the Group entered into related party transactions worth £596.41. This figure comprises £285.27 paid to the House of Lords and House of Commons Catering Services for the provision of hospitality to BAPG visitors, £33.77 for inhouse printing and £277.37 on small gifts. (2022-23: £4,541 total related party transactions comprising £4,278 for catering, £92 printing and £171 on sundry items from the Parliament shop).

The Officers and members of the BAPG Executive Committee do not receive a remuneration for their role.

#### 11. Events after the reporting date

In accordance with the requirements of IAS 10, post Statement of Financial Position events are considered up to the date on which the accounts are authorised for issue by the Accounting Officer. This is the date of the Independent Auditor's report of the Comptroller and Auditor General. I can confirm there are none.

# 2-6 April 2023

Four BAPG members: Robert Courts, MP, Jane Stevenson, MP, Alex Davies-Jones, MP and the Lord Watts, visited Texas to better understand the commercial opportunities afforded by America's second largest (and fastest growing) state and the political power that sits outside the beltway as well as establish a political/parliamentary relationship with Texas state legislators, particularly around influencing policy debate on climate change and energy transition.

The group visited Houston, Austin and Dallas in a programme arranged by the British Consulate General Houston, in conjunction with the BAPG.

Robert Courts, MP has written a report on the visit which is available from the BAPG Secretariat.

# 19<sup>th</sup> April

As part of its work on climate change this year the LSE Phelan US Centre held an essay competition for Masters' students with the prompt, 'What responsibility does the US have to the rest of the world on climate change?' and invited the BAPG to host a presentation of the winning essay as a way to engage students with MPs and the policymaking process.

We are grateful to BAPG members, The Rt. Hon. Greg Clark, MP (Chair, Select Committee on Science and Technology) and Matt Western, MP (Shadow Minister for Higher Education) for hosting the presentation in Parliament joined by Kerry McCarthy, MP (the Shadow Minister for Climate Change) and The Rt. Hon. the Lord Haselhurst (member of the BAPG Executive Committee). The essay competition winner Oscar Parry and runner-up, Jibran Raja, engaged in a robust Q&A session which highlighted the value of hearing the voice and insights of students on important issues.

# 24th April

The BAPG Administrator met online with Rory Newbery and Sydney Smith of the Cultural Affairs team at the US Embassy to discuss the arrangements for this year's US government sponsored Legislative exchange to the US.

# 27th April

The BAPG Administrator met with the NAO to discuss the audit of the BAPG Accounts 2021-22, which was almost complete.

# 27th April

The BAPG Administrator met with the new Head of InterParliamentary Relations in the House of Lords, Susie Latta, to discuss the work of the BAPG and its programme of activities.

# 28th April

The BAPG Administrator met virtually with Evelyn Okello-Boafo of HOC Finance, who prepares the BAPG Accounts to discuss the timetable for preparation of the BAPG Accounts 2023-24.

#### 19th March

BAPG members were invited to a London POTUS Group online event with Professor Andrew Rudalevige, Thomas Brackett Reed Professor of Government at Bowdoin College and distinguished scholar who specializes in the modern American presidency, who gave a talk on 'The 2024 Campaign for the White House and How Donald Trump would use Presidential Power in a Second Term'.

#### 25th March

At the request of the British Defence Staff United States at the British Embassy Washington DC, the BAPG arranged a tour of Parliament and tickets to the Commons gallery for two senior members of staff to Rep. Elise Stefanik (R-NY) and Rep. Michelle Fischbach (R-MN).

#### REPORT ON THE WORK OF THE GROUP DURING 2023-2024 (not subject to audit)

The Annual General Meeting of the Group took place on 12th July 2023 at which the Speaker of the House of Commons, The Rt. Hon. Sir Lindsay Hoyle, MP, presided.

It was reported that in the 12 months from April 2022 to April 2023 there had been one Annual Conference in the UK, the deferred 2021 Annual Conference, with a delegation from the US Senate. We had hoped to also host the 2022 Annual Conference in the UK with a delegation from the US House of Representatives, following the US Midterm Elections, but the meeting had to be deferred due to the House BAPG not being able to organise a delegation for the scheduled dates of the exchange. In all, 18 members had visited the US during the year under the auspices of the BAPG.

During the 12 months to April 2024, regretfully there had been no Annual Conference, either with the Senate or the House of Representatives, despite our best efforts. The underlying issue has been a delay in the appointment of a Democratic lead in both the Senate and House BAPG delegations, without whom we can plan a conference. The Democratic leadership in the House of Representatives has now appointed a co-chair to the House BAPG delegation (in late January 2023) and we are trying to determine suitable dates for an exchange, complicated by general elections in both countries. The Senate leadership has not yet confirmed a Democratic chair for the Senate BAPG delegation, but we hope progress will be made on this following the US general election.

Despite there being no Annual Conference, we have had the opportunity to engage with US Members of Congress visiting the UK, meeting with 26 Members of Congress in August 2023, led by Rep. Steve Scalise (R-Louisiana) and Rep. Terri Sewell (D-Alabama), who were in London to take part in the 'Transatlantic Capital to Capital Exchange' conducted by The Ripon Society and the Franklin Center for Global Policy Exchange and also by way of an exchange hosted by the Association of Marshall Scholars in January 2024 in Oxford and London co-chaired by Rep. Mark Green (R-Tennessee) and Rep. Jim Himes (D-Connecticut), attended by BAPG officers and members.

In all, 13 members had visited the US during the year under the auspices of the BAPG.

There were the following visits to the US:

- In April 2023, the BAPG sent four members to Texas to better understand the commercial opportunities afforded by America's second largest state and to establish a political / parliamentary relationship with Texas state legislators.
- In July 2023, five members with no or little prior experience of the US, went to the United States with the BAPG to take part in a US government co-sponsored 'International Visitor Leadership Programme' to learn about the American political system at the federal, state and local levels, with emphasis on the role and organisation of Congress.

 In March 2024, the BAPG sent four members to the US Midwest, to Kansas and Missouri, to look at how American industry and agriculture is regenerating by leveraging traditional strengths in agricultural innovation to unlock funding from federal funding programmes, to build Parliamentary links with both States and to explore the opportunities for increased trade and investment.

In February 2024, the BAPG partnered with BritishAmerican Business in co-hosting a reception for the American Ambassador, H.E. Hon. Jane Hartley, in the Speaker's State Rooms by kind permission of Mr. Speaker. Ambassador Hartley brought along with her 19 senior members of staff from the Embassy to meet Parliamentarians and leaders of US / UK business to establish contacts and discuss matters of common interest. BAB arranged payment of the refreshment costs.

Over the year, the BAPG has been pleased to host VIPs from the United States at the request of the Foreign Office, the American Embassy or directly from the offices of U.S. legislators. Arrangements were also made for the Marshall Scholars to visit Parliament and to meet with a Parliamentarian for a question and answer exchange.

Contact with the United States Embassy in London has been well maintained throughout the year and a significant part of our programme is dependent on good liaison with both the U.S. Embassy and the Foreign Office. Our extensive thanks are due to the North America Department at the Foreign Office for the very informative briefings which they are always kind enough to provide for BAPG delegations and to the British Embassy in Washington D.C. and the Consulates across the USA for their very great input into the programmes arranged for our delegations. We are grateful for all their very considerable help that they give to the BAPG thereby enabling us to maintain our programme from year to year.

We are also extremely grateful to the Speaker of the House of Commons and CPA-UK who kindly provide gallery tickets for visiting Americans.

# MINUTES OF THE ANNUAL GENERAL MEETING OF THE BRITISH-AMERICAN PARLIAMENTARY GROUP HELD ON WEDNESDAY, 12<sup>TH</sup> JULY 2023 AT 3.30 P.M. IN THE JUBILEE ROOM

The Speaker of the House of Commons, The Rt. Hon. Sir Lindsay Hoyle, MP, welcomed everyone to the AGM.

He drew members attention to the list of Apologies set out on the chairs.

# 1. Apologies

Apologies for absence were conveyed from the Prime Minister together with 23 others.

# 2. Minutes of the last Meeting

The Minutes of the last meeting, having been circulated in the Annual Report at pages 41-51, were approved and signed as a true record of the proceedings.

# 3. Matters Arising

There were no matters arising from the Minutes of the last meeting, which were not due for discussion under a later item.

# 4. <u>To Receive the Annual Report from the Executive Committee for April 2022 to April 2023 and</u> the Accounts for the Year Ending 31<sup>st</sup> March 2023

The Chair advised that although this came under one agenda item, it was in fact in two parts: the first being the Annual Report and the second being the Accounts.

The Chair called on The Rt. Hon. John Healey, MP, Joint Honorary Vice Chair, to report on the work of the group during the period April 2022 to April 2023.

Mr. Healey welcomed everyone and thanked Mr. Speaker for agreeing to preside at the AGM, members were very grateful to have him here.

Mr. Healey reported that the written report of the last year is in the Annual Report on pages 36-40.

Mr. Healey drew out some highlights from that report. During the 12 months to April 2023, there had been one Annual Conference with Americans. It was the 2021 Annual Conference, which had been of course deferred by the pandemic, with a delegation from the Senate.

We had also hoped to host the 2022 Annual Conference with a delegation from the US House of Representatives following the US Midterm Elections, but in the end, had to defer the meeting due to the House BAPG not being able to get a delegation together in time.

The deferred 2021 Annual Parliamentary / Congressional Conference was held in London and West Sussex from 1st to 3rd September 2022. While we had at one time expected nine Senators

to take part in the exchange, in the end six Senators came, accompanied by their spouses and staff. Not with standing that, they were very senior Senators, including the President pro tempore and Chair of the Senate Appropriations Committee, Senator Patrick Leahy (D-Vermont), and the Vice Chair of the Senate Appropriations Committee, Senator Richard Shelby (R-Alabama). There were some very productive discussions over a couple of days conducted at the Home of Rolls Royce Goodwood, the luxury car maker, and Wilton Park, a government conference centre, set in the South Downs National Park.

We also had 18 members visit the US during the year by means of the following visits:

- In May 2022, the BAPG sent six members to San Francisco, Sacramento and Los Angeles to look at zero emission & autonomous vehicles policy, regulation, and commercial opportunity, arranged by the British Consulates General San Francisco and Los Angeles, in conjunction with the BAPG.
- In July 2022, after a hiatus of two years due to the COVID-19 pandemic, eight members with
  no or little prior experience of the US, went to the United States with the BAPG to take part
  in the regular US government co-sponsored 'International Visitor Leadership Programme' to
  learn about the American political system at the federal, state and local levels, with emphasis
  on the role and organisation of Congress.
- In early December 2022, four members attended the Harvard University Institute of Politics' Bi-Partisan Programme for Newly Elected Members of Congress as observers. The British Members of Parliament are the only foreign legislators invited to observe the programme and it provides an unrivalled opportunity for members to develop contacts with new Members of Congress at the start of their careers. The programme comprises intensive seminars on major public policy issues such as foreign policy, health care and the federal budget, led by prominent scholars and practitioners representing viewpoints from across the political spectrum and workshops focused on the "how" of getting things done in Washington, led by current and former senior officials from Congress, the White House, cabinet departments, regulatory agencies, and the national media.

In October 2022, the BAPG partnered with BritishAmerican Business (BAB) in co-hosting a reception for the new American Ambassador, H.E. Hon. Jane Hartley, in the Speaker's State Rooms by kind permission of Mr. Speaker. Ambassador Hartley brought along with her 19 senior members of staff from the Embassy to meet Parliamentarians and leaders of US / UK business to establish contacts and discuss matters of common interest.

In February 2023, the BAPG in partnership with Wilton Park, an executive agency of the UK Foreign, Commonwealth and Development Office, hosted a reception event 'Highlighting the Transatlantic Relationship' in the Speaker's State Rooms, with kind support from Virgin Atlantic. The American Ambassador, H.E. Hon. Jane Hartley, joined Shanker Singham, CEO of Competere, in conversation on the state of the transatlantic relationship, which was followed by a networking reception.

Over the year, the Group has been able to arrange meetings/tours/lunches for visiting U.S. Members of Congress/State legislators/other visiting US VIPs and this is a part of the Group's role which we are always keen to expand and develop.

The Group's complete list of activities for the year are shown on pages 26 to 35 in the Annual Report. They show the contribution the Group has made over the year to promoting good relations with the US and the role which the Group has played in the programmes of American visitors.

Mr. Healey paid tribute to the co-operation which the Group had received over the year from the American Embassy, particularly from the Political and Cultural Affairs Departments, and also for the support from the Charge d'Affaires, a.i. of the US Embassy, Philip Reeker. We are also indebted to the North America Department at the FCDO and to the British Embassy in Washington D.C. on whom a significant part of our programme is dependent. The British Embassy is particularly helpful when it comes to arranging meetings and other aspects of any programme for BAPG delegations to Washington D.C. as are the Consuls-General in other parts of the US.

Mr. Healey ended by thanking the Administrator on behalf of the Group. He commented, she is the one person who keeps so much of everything we are able to do going, which was warmly supported by members.

The Chair thanked the Vice Chair and confirmed there were no questions before inviting the Joint Honorary Treasurer, John Spellar, to present the Accounts.

Mr. Spellar thanked the Speaker for presiding over the meeting. He reported that the Accounts appear on pages 3-25 in the Annual Report of the Executive Committee 2022-2023.

He advised that normally the Accounts would have been audited and certified by the NAO, but post pandemic, it has been dealing with a backlog and has pushed back audit of the BAPG accounts to after the main House of Commons and Lords Annual Reports and Accounts have been certified. However, we can still endorse the Accounts, subject, of course, to their certification by the Comptroller and Auditor General.

He proposed going through the Accounts and drawing members' attention to one or two of the issues there.

If members look at cash in the bank, we have got a balance of £80,702 there; £75,543 was held with RBS, £4,858 with NatWest and £301 with Nationwide.

Cash has reduced by £66,255 in the year, because of expenditure, which obviously post pandemic had moved up compared with previous years and that obviously has impacted on our reserves.

We would like to thank the House authorities for being understanding in being able to move monies between years, recognizing the extraordinary circumstances, which we were facing.

Members can then go through, look at Programme Expenditure, Income from the previous year - once again, we highlight to you that Life Subscriptions income is treated as a pre-payment over a period of ten years with 1/10th of income received released each year - Staff Costs. He endorsed what John Healey had said regarding the superb work that is undertaken by the Administrator in doing this, particularly with some of the difficult times with delegations with regulations that we have had to go through, and so on.

He thought the rest was really pretty unexceptional and wished to move endorsement of the Accounts.

Mr. Speaker invited any questions on either the Annual Report or the Accounts, of which there were none. There was unanimous agreement to accept the adoption of the Annual Report and Accounts 2022-23, subject to their certification by the Auditor General.

And that, Stephen **Flynn**, MP, in his position as leader of the SNP Westminster Group, be elected as a Vice President, as is the tradition with the leaders of the main opposition parties.

The Chair put forward a formal motion that they be passed, which was unanimously agreed.

The Chair on behalf of the group paid tribute to The Rt. Hon. the Baroness **Boothroyd**, OM, a former Vice President (2000-2023) and Joint President (1992-2000), who had sadly passed away on 26<sup>th</sup> February 2023, and also to The Rt. Hon. the Lord **Morris** of Aberavon, KG, QC, a former Vice President (2011–2023) and longstanding member of the BAPG Executive Committee (2002-2011), who sadly passed away on 5<sup>th</sup> June 2023. They were both extremely supportive of the group and its objectives and will be greatly missed.

The Chair reported that there will be a memorial service that will be announced to both at some point. The chair invited members to remember them.

The Chair then moved on to the Officers of the Group, seeking to formally ratify their appointments in their respective roles.

The government Vice Chair, The Rt. Hon. Ben **Wallace**, MP, has now completed the third year of his three-year stint. He is always most supportive of the Group and we are most grateful to him for having been our Vice-Chair during this time.

The Rt. Hon. John **Healey**, MP, Opposition Vice Chair, has now completed the third year of his three-year term. He has given the Group a great deal of his time and support over the years, including chairing Executive Committee meetings, hosting events and always being happy to give both help and advice when asked.

It is incumbent on the Executive Committee to recommend their successors.

In the role of BAPG Government Vice Chair, the Executive Committee recommend, The Rt. Hon. James **Cleverly**, MP, the Foreign Secretary, and in the role of Opposition Vice Chair, the Executive Committee recommend, The Rt. Hon. David **Lammy**, MP, Shadow Foreign Secretary, each for the term of three years.

The Chair confirmed their acceptance, which was unanimously agreed.

The Vice Chair from the House of Lords, The Rt. Hon. the Baroness Jay of Paddington, has completed the second year of her three-year term. We are most grateful to Baroness Jay for her support of the group's affairs; participating in Parliamentary / Congressional conferences, chairing online briefings and discussion events for the Group and leading on an initiative to establish a series of exchanges dedicated to exploring issues of common interest between women legislators on each side of the Atlantic.

The Rt. Hon. Sir Greg **Knight**, MP, the Honorary Secretary, has completed his eighth year in that office, which has a maximum term of eight years. The Group has been hugely fortunate to have such a dedicated and hardworking Honorary Secretary who has given an enormous amount of his time to the Group's affairs.

In accordance with rule 8 (b), the Executive Committee recommends that The Rt. Hon. John **Spellar**, MP, previously Joint Honorary Treasurer to the BAPG, should become the new Honorary Secretary and that The Rt. Hon. Sir Greg **Knight**, MP, should become the new Joint Honorary Treasurer, alongside Sir Christopher **Chope**, OBE, MP, who we are extremely pleased has agreed to continue in the role.

We are very grateful to Sir Greg, John and Sir Christopher for the considerable amount of time they have given and continue to give to the Group's affairs and the hard work which they do is very much appreciated.

The Chair put the motion to the meeting that those Officers should be approved for the year ahead, asking if everyone was content or against. There was unanimous agreement that the Officers be approved.

# 6 To Elect 18 Members to serve on the Executive Committee 2023-24

# 7. Any Other Business

The Chair called on the outgoing Honorary Secretary, The Rt. Hon. Sir Greg Knight, MP, who wished to make some announcements.

Sir Greg mentioned a few items:

Members are invited to stay on after the AGM to meet the Deputy Chief of Mission to the US Embassy, Matthew Palmer, who will be joined by the Minister Counsellor for Political Affairs, Joe Pennington, and Political Specialist, Justine Lancaster, for an informal discussion on US foreign policy priorities and the US political landscape.

# 16-25 July 2023

Six out of an original eight Members of Parliament, with no or little prior experience of America, will travel to the United States to take part in an annual US government sponsored International Visitor Leadership Programme (IVLP), to learn about the US Legislative Process. The programme will open in Washington DC and comprise an overview of the federal system of government and how the various branches of government interact. This will be followed by meetings at key US government departments and with congressional counterparts. The middle weekend will be spent with a Member of Congress in his/her home district and the final two days will be spent in Boston where the participants will reunite to examine a state capital legislature and other issues of interest.

# 8<sup>th</sup> August

The BAPG is making arrangements to host a large delegation of Members of Congress who are visiting London to take part in the 'Transatlantic Capital to Capital Exchange' conducted by The Ripon Society and the Franklin Center for Global Policy Exchange. The Ripon Society is an American centrist Republican public policy organization and think tank and the Franklin Center is an American non-partisan public policy organization.

They have confirmed to date 32 Members of Congress taking part in the conference (23 Republicans and nine Democrat members) who will be accompanied by nine congressional staffers. The congressional delegation will first be given a guided tour of Parliament followed by a bilateral meeting with Parliamentarians at 2pm in the Grand Committee Room. If members expect to be around then and interested to meet the congressional delegation, would they please let the Administrator know? It may be helpful to know that they only have an hour for the meeting and we have already had quite a good response. Provisional topics signposted for discussion are: transatlantic trade, supply chains, Ukraine, energy sufficiency, defence/security cooperation and China, time allowing.

# September / October

We are very excited to be planning with the Chair of the Congressional Women's Caucus, Rep. Kat Cammack (R-Florida), a series of online exchanges dedicated to exploring issues of common interest between women legislators on each side of the Atlantic. The first online forum is planned for September / October and the date will be confirmed in the coming weeks.

# **Annual Parliamentary / Congressional Conferences**

The core of the BAPG's programme is alternate Annual Conferences with the House of Representatives and the Senate. The meetings are held in the U.S. and the UK, alternating every two years.

We hope to host the deferred 2022 Annual Parliamentary / Congressional Conference this (financial) year as well as send a delegation to Washington DC to meet with Senators as part of the 2023 Annual Conference. Both are dependent on the leadership in both Houses of Congress appointing a new chair to the respective BAPGS, which has been delayed since the start of the new Congress in January 2023. As soon as the Chairs have been appointed, we can work with their respective offices to determine suitable dates for the exchanges.

Through the Chair, Sir Greg wished to thank Ben Wallace, John Healey, John Spellar, Sir Christopher Chope and the Administrator for the work they have done during the year and for the support they have given to him.

In closing, Sir Greg reminded members that Group functions/visits are always advertised by means of the All-Party & Associated Group Notices, the BAPG website <a href="www.bapg.org.uk">www.bapg.org.uk</a> and via email to the BAPG membership.

The Chair thanked Sir Greg and invited any questions about the forward programme, of which there were none.

The Chair asked members if they had any other business that they wish to raise before he closed the meeting.

The Chair thanked the Administrator for all the work that she does, which was much greatly appreciated.
